The application submitted by the Principal, De Paul
Institute of Science & Technology, Angamaly vide paper read (1)
for starting new MBA course for the academic year 2008-'09 was
processed and placed before the Syndicate for decision, as per
the provisions contained in the Act and Statutes of the
University.

In the wake of various communications received from
Government, the request of the college for starting new MBA
course was considered and based on the undertaking submitted
by the college, the recommendation of the University was
forwarded to Government vide paper read (4).

Meanwhile Government vide letter dated 26.3.'08 informed
that affiliation to new colleges/courses shall be granted to
those institutions which have entered into an agreement with
the Government.

Government vide G.O. read (5) accorded sanction to
De Paul Institute of Science & Technology, Angamaly, for
executing an agreement for starting MBA course for the year
2003-'09.

First Approval for MCAU & Govt of Kerala

After executing agreement with the institution, Government vide G.O. read (6) issued NOC to De Paul Institute of Science and Technology, Angamali for starting MBA course with an annual intake of 60 students for the academic year 2008-'09 as per the conditions, specified in the G.O. read (5) and as per the terms and conditions stipulated in the agreement executed by the Principal, De Paul Institute of Science and Technology with the Government and also on the conditions stated in the AICTE approval order read (2) above.

In the light of the execution of agreement and NOC received from the Government, the Hon'ble Vice-Chancellor subject to ratification by the Syndicate has granted provisional affiliation to start MBA course at De Paul Institute of Science and Technology for the academic year 2008-'09 with specific orders to complete admission on or before 27.11.2008, subject to honouring the undertaking dated 2.9.'08 submitted by the Principal of the institution.

The provisional affiliation granted is subject to the following conditions:

1. The provisional affiliation granted is for the academic year 2008-09 only
2. The educational agency shall remit Rs. 50,000/- (Rupees Fifty thousand only) towards affiliation fee for MBA course with two weeks of receipt of this order.
3. The educational agency shall submit an undertaking in a stamped paper worth Rs. 50/- to the effect that it will abide by the rules and regulations, orders and instructions issued from time to time by the University/State Govt./ Central Govt/accrediting agency regarding admission to the courses.
4. The admission to the course shall be made within the sanctioned strength and strictly in accordance with the rules and regulations framed by the University/AICTE and the Government from time to time.
5. The college shall honour the undertaking dated 2.9.'08 submitted by the Principal regarding additional facilities without fail.
6. The college will have to prepare students for the University examination as per the approved scheme and syllabus of the University.
7. The college shall submit the list of students admitted to the course along with other relevant details within 15 days after closing of admission.
8. The college shall observe the admission norms regarding the eligibility of candidates and the norms of reservation framed by the Government/University/AICTE. Admission to the course shall be made strictly in accordance with the AICTE guidelines.

9. Intake of students in the sanctioned batch will be 60.
10. Students Affiliation fee collected on one time basis from all students @ Rs. 250/- and Annual Administration fee @ Rs. 500/- per student shall be remitted to the University within 15 days after closing of the admission.
11. Collection of Annual Administration Fee from the students under any circumstance is not permitted.
12. Non-compliance with any of the above mentioned conditions would result in the withdrawal of affiliation without any notice.

Orders are issued accordingly.


