ORDER

The applications submitted vide paper read (1) above, by the Principal, De Paul Institute of Science & Technolgy, Angamaly, Ernakulam for starting new Unaided Self financing MCA(Lateral Entry) and MCA Dual Degree (DDMCA) courses, for the academic year 2014-15, were considered by the University. As per the report of the Inspection Commission constituted vide paper read (2) above and approval orders from AICTE read as (3) & (4) above, University sent its recommendation for the views/NOC of Government of Kerala vide paper read (5)above.

Government of Kerala, vide paper (6) above, issued NOC for De Paul Institute of Science & Technolgy, Angamaly, Ernakulam for starting new Unaided Self financing MCA(Lateral Entry) with an intake of 40 seats and MCA Dual Degree (DDMCA) course with an intake of 60 seats, for the academic year 2014-15.

In the light of the NOC from Government of Kerala, the Hon'ble Vice Chancellor, exercising powers u/s 3.10(17) of Mahatma Gandhi University Act, 1985, has granted provisional affiliation for starting new Unaided Self financing MCA(Lateral Entry) with an intake of 40 seats and MCA Dual Degree (DDMCA) course with an intake of 60 seats, in De Paul Institute of Science & Technolgy, Angamaly, Ernakulam, during the academic year 2014-15.

Sanction has, therefore, been accorded to grant provisional affiliation for starting a new Unaided Self financing MCA(Lateral Entry) with an intake of 40 seats and MCA Dual Degree (DDMCA) course with an intake of 60 seats, in De Paul Institute of Science & Technolgy, Angamaly, Ernakulam, during the academic year 2014-15.

The provisional affiliation granted is subject to the following conditions:

- 1. The provisional affiliation is granted initially for a period of one academic year only
- 2. The admission to the course shall be made within the strength sanctioned by the University and AICTE.
- 3. The Educational Agency shall furnish an undertaking in a stamp paper worth Rs. 100/- to the effect that it will abide by the rules, regulations and instructions issued by the University, State Government, Regulatory Body regarding the admissions to the courses from time to time.
- 4. The Management shall prepare and present the students in accordance with the laws of the University for the examination and as per the approved scheme and syllabus of the University in the subjects concerned.

- 5. The College shall observe the admission norms regarding the eligibility of candidates and the norms of reservation framed by the Government, AICTE and the University
- 6. The Educational Agency shall set apart 50% of the seat of the courses being filled up by the Government or such authority determined by the Government or such authority determined by Government and the remaining 50% filled up by the Educational Agency on the basis of merit.
- 7. The college shall submit the list of students admitted and remit the following fees due to University within 15 days after closing admission:

a. Students Affiliation Fee

Rs. 350/- per Student (One time fee to be remitted at the time of admission)

b. University Union Fee

Rs. 50/- per Student per year

University Sports Affiliation Fee

Rs. 150/- per Student(Rs. 75/- to be remitted to the University and Rs.75/-

to be utilized by the College)

d. Student's Welfare Fund

Rs. 20/- per Student per year

e. Student's Insurance

Rs. 10/- per Student per year

f. Annual Administration Fee

Rs. 700/- per Student per year

- 8. The Educational Agency shall remit Rs. 1,00,000/- (Rupees One Lakh only) each as Course Affiliation Fee towards the new MCA(Lateral Entry) course and MCA Dual Degree (DDMCA) course sanctioned to the University Fund.
- 9. The admission to the courses shall be made as per the existing rules of admission and provision made for Unaided Colleges/Courses.
- 10. Collection of Annual Administration Fee from the Students under any circumstance is not
- 11. Non-compliance with any of the above mentioned conditions will result in the withdrawal of the affiliation without any notice.


