## ORDER

The application submitted by the Principal, De Paul Institute of Science & fechnology, Angamaly vide paper read (1) above for starting PG/UG courses for the academic year 2011-12 was considered by a University. The Inspection Commission constituted as per paper read (2) and (3) above, assessed the facilities available with the college and recommended to sanction the courses B Com Model II (Finance & Taxation) with 40 seats and MA Multimedia and MacCom Finance with 12 seats each during 2011-12.

The recommendation was forwarded to the Government of Kerala vide paper read (4) above for its views/NOC. The Government vide paper read (5) above issued Administrative Sanction for starting Self Figure Cing/ Unaided B Com Model II (Finance & Taxation) with 40 seats and MA Multimedia and M.Com Finance with 12 seats each in De Paul Institute of Science & Technology, Angamaly under De Paul Education Trust, Angamaly for the academic year 2011 2. An Undertaking as per paper read (6) above was also submitted by the Principal, De Paul Institute of Science & Technology, angamaly, avowing to submit the Government NOC within three weeks.

After considering the administrative sanction and the undertaking submitted by the College Principal, the Vice Chancellor excising powers under section 3.10(17) of Mahatma Gandhi University Act, 1985 has granted provisional affiliation for, B Com Model II (Finance & Taxation) with 40 seal and MA Multimedia and M.Com Finance with 12 seats each at De Paul Institute of Science & Technology, Angamaly during 2011-12.

Sanction has, therefore, been accorded to grant provisional affiliation for B Com Model II (Finance & Taxation), MA Multiredia and M.Com Finance courses during 2011-12 at De Paul Institute of Science & Technology, Angamaly with an annual intake of 40 students for UG and 12 students each for PG courses on condition that admission to UG courses shall be made from 2012-13 academic year only.

The Provisional Affiliation granted is subject to the following conditions.

- 1. The provisional affiliation is granted initially for a period of one academic year only.
- 2. The Management shall prepare and present the students in accordance with the laws of the University for the examination and as per the approved scheme and syllabus of the University in the subjects concerned.
- 3.As per G.O read(5) the Educational Agency shall set apart 50% of the seats of the course for being filled up by the Government or such authority determined by Government on the basis of merit and reservation principles followed by the Government and the remaining 50% filled by the Educational Agency on the basis of merit.

f) Collection of Annual Administration fee from the students under any

circumstances is not permitted.

- g) Students affiliation fee @ Rs.250/- for the PG courses and Rs.200/- for UG courses collected on one time basis from all students shall be remitted to the University within fifteen days after closing of the admission.
  - 5. The Educational Agency shall furnish an undertaking in a stamp paper worth Rs.50/- to the University to carry out faithfully, the provisions of the Act, Statute, Ordinance and Regulations and the directions issued by the University from time to time in so far as they are related to the college. The Principal of the college shall endorse the undertaking.

6. The college shall submit the list of students admitted and remit the fees due to

University within 15 days after closing admission.

7. Non-compliance with any of the above conditions would lead to the withdrawal of the affiliation without any notice.

Orders are issued accordingly.
