The applications submitted vide paper read (1) above, by the Principal, De Paul Institute of Science & Technology, Angamaly, Ernakulam for starting additional batch in B Com Model II (Vocational: Finance & Taxation), M Com Finance and increase in intake in existing B Com Model II (Vocational: Computer Applications) and BCA courses for the academic year 2013-14 were considered by the University. As per the reports of the Inspection Commissions constituted vide paper read (2) & (3) above, University sent its recommendation for the views/NOC of Government of Kerala vide paper read (4) above.

Government of Kerala, vide paper read (5) & (6), issued NOC for starting additional batch in B Com Model II (Vocational: Finance & Taxation) (40 seats), M Com Finance (15 seats) and increase in intake in existing B Com Model II (Vocational: Computer Applications) (40 to 50 seats) and BCA (40 to 50 seats) courses in De Paul Institute of Science & Technology, Angamaly, Ernakulam during the academic year 2013-14.

In the light of the NOC issued by Government of Kerala, the Vice Chancellor exercising powers u/s 3.10(17) of Mahatma Gandhi University Act, 1985, granted provisional affiliation to the following programmes in De Paul Institute of Science & Technology, Angamaly, Ernakulam, for the academic year 2013-14:

- 2. The Management shall prepare and present the students in accordance with the laws of the University for the examination and as per the approved scheme and syllabus of the University in the subjects concerned.
- 3. As per G O read (5) & (6) above, the Educational Agency shall set apart 50% of the seats of the course for being filled up by the Government or such Authority determined by Government on the basis of merit and reservation principles followed by the Government and the remaining 50% filled by the educational agency on the basis of merit.



- c) Students Welfare Fund @ Rs. 10/- per student per year.
- d) University Union Fee @ Rs. 30/- per student per year.
- e) Sports Affiliation fee @ Rs. 150/- per student per year to be utilized in the ratio @ 50:50 by the University and the College.
- f) Collection of Annual Administration fee from the students under any circumstances is not permitted.
- g) Students affiliation fee @Rs. 300/- for UG courses and Rs. 350/- for PG courses collected on one time basis from all students shall be remitted to the University within fifteen days after closing of the admission.



- 5. The enhanced rate of Tuition Fee is applicable from 2013-14 admissions only. Changes (if any) in the rate of Tuition Fee will be intimated later.
- 6. The Educational Agency shall furnish an undertaking in a stamp paper worth Rs. 100/- to the University to carry out faithfully, the provisions of the Act, Statute, Ordinance and Regulations and the directions issued by the University from time in so far as they are related to the college. The Principal of the college shall endorse the undertaking.
- 7. The college shall submit the list of students admitted and remit the fees due to University within 15 days after closing admission.
- 8. Non-compliance with any of the above conditions would lead to the withdrawal of the affiliation without any notice.

Orders are issued accordingly.
