ORDER

The application submitted vide paper read (1) above, by the Principal, De Paul Institute of Science & Technology, Angamaly, Ernakulam for starting new M Phil Course in Business Studies for the academic year 2013-14 was considered by the University. As per the report of the Inspection Commission constituted vide paper read (2) and Minutes of the Syndicate Standing Committee on Affiliation read (3), University sent its recommendation for the views/NOC of Government of Kerala vide paper read (4) above.

Government of Kerala, vide paper read (5), issued NOC for starting new M Phil Course in Business Studies (8 seats) in De Paul Institute of Science & Technology, Angamaly, Ernakulam under De Paul Education Trust, Angamaly, Ernakulam for the academic year 2013-14.

In the light of the NOC issued by Government of Kerala, the Vice Chancellor exercising powers u/s 3.10(17) of Mahatma Gandhi University Act, 1985, granted provisional affiliation for starting new M Phil Course in Business Studies with 8 seats in De Paul Institute of Science & Technology, Angamaly, Ernakulam, for the academic year 2013-14:

Sanction has, therefore, been accorded to grant provisional affiliation for starting new M Phil Course in Business Studies with 8 seats in De Paul Institute of Science & Technology, Angamaly, Ernakulam for the academic year 2013-14, subject to the following conditions:

- 1. The provisional affiliation is granted initially for a period of one academic year only, subject to the approval of Scheme & Syllabus.
- 2. The Management shall prepare and present the students in accordance with the laws of the University for the examination and as per the approved scheme and syllabus of the University in the subjects concerned.
- 3. As per G O read (5) above, the Educational Agency shall set apart 50% of the seats of the course for being filled up by the Government or such Authority determined by Government on the basis of merit and reservation principles followed by the Government and the remaining 50% filled by the educational agency on the basis of merit.

- 4. The details of Course Affiliation Fee/Tuition Fee, Special Fee (if any)/Students Affiliation Fee/Annual Administration Fee etc will be intimated later.
- 5. Other fees to be remitted are detailed below:
 - a) Students insurance premium @ Rs. 10/- per student per year.
 - c) Students Welfare Fund @ Rs. 10/- per student per year.
 - d) University Union Fee @ Rs. 30/- per student per year.
 - e) Sports Affiliation fee @ Rs. 150/- per student per year to be utilized in the ratio @ 50:50 by the University and the College.
 - f) Collection of Annual Administration fee from the students under any circumstances is not permitted.
- 6. The Educational Agency shall furnish an undertaking in a stamp paper worth Rs. 100/- to the University to carry out faithfully, the provisions of the Act, Statute, Ordinance and Regulations and the directions issued by the University from time in so far as they are related to the college. The Principal of the college shall endorse the undertaking.
- 7. The college shall submit the list of students admitted and remit the fees due to University within 15 days after closing admission.
- 8. Non-compliance with any of the above conditions would lead to the withdrawal of the affiliation without any notice.
